# SOFTWARE LICENSE AGREEMENT For Non-Production Use Only

As used in this Software License Agreement ("Agreement"), the words "Solace" means Solace Corporation, and "Licensee" means either, you as an individual user or your employer (if you are accepting this Agreement on behalf of your employer). By installing, downloading, accessing, or using the Software, you agree to the terms and conditions of this Agreement. If you do not agree to such terms and conditions, you must not access or use the Software. If you are receiving the Software on behalf of a legal entity, you represent and warrant that you have the actual authority to agree to the terms and conditions of this Agreement on behalf of such entity.

#### 1. LICENSE GRANT AND CONDITIONS.

- **1.1. License.** Solace hereby grants to Licensee a limited, non-exclusive, non-transferable, license to use the Software solely for internal, non-production purposes such as evaluation, testing, and prototyping. This license expressly prohibits commercial use or deployment in production environments.
- 1.2. Restrictions. Licensee will not: (i) use the Software for production purposes or to process live data; (ii) assign, sublicense, sell, rent, lease or distribute the Software; (iii) modify, translate, reverse engineer, decompile or create derivative works; (iv) remove or alter any proprietary notices or labels; (v) use the Software to provide services to third parties; or (vi) use or attempt to use the Software in violation or contravention of any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions, or other than as expressly set forth in this Agreement.
- **1.3. Conditions.** Licensee acknowledges that future updates or modifications to the Software by Solace may remove or restrict previously existing functionality.
- 1.4. Publicly Available Software. The Software may include components distributed under third-party licenses that govern ("Publicly Available Software"). The Software may include components distributed under third-party licenses ("Publicly Available Software"). Licensee may use such Publicly Available Software in conjunction with the Software as permitted by this Agreement. However, nothing in this Agreement restricts any broader rights Licensee may have under the applicable third-party licenses governing the Publicly Available Software.

#### 2. TERM AND TERMINATION.

This Agreement will commence upon Licensee's download or installation of the Software and continue until terminated. Solace may terminate this Agreement immediately without notice if Licensee: (a) uses the Software in production or commercial environments, (b) violates any usage restrictions, (c) redistributes or sublicenses the Software without authorization, or (d) breaches any other material term of this Agreement. Upon termination of the Agreement, the license will automatically terminate, and the Licensee will immediately stop using the Software and destroy all copies.

## 3. INTELLECTUAL PROPERTY.

As between the parties, Solace will retain all right, title, and interest in the Software, and all intellectual property rights therein. Solace reserves all rights not expressly granted to Licensee in this Agreement.

#### 4. CONFIDENTIALITY.

Licensee will treat the Software as confidential information and will not disclose it to any third party without Licensor's prior written consent.

### 5. DISCLAIMER.

The Software is provided "as-is" and "as available" without any warranty, indemnification, support, or condition of any kind, whether express, implied, or statutory. Solace disclaims all warranties, including without limitation any implied warranties of merchantability, fitness for a particular purpose, title, or non-infringement.

#### 6. LIMITATION OF LIABILITY.

In no event will Licensor be liable for any indirect, incidental, special, exemplary, or consequential damages arising out of or related to this Agreement, even if advised of the possibility of such damages. Licensor's total liability will not exceed \$0, except where prohibited by applicable law, in which case Licensor's total liability will not exceed \$100.

## 7. GOVERNING LAW.

This Agreement will be governed by the laws of the Province of Ontario, without regard to its conflict of laws principles.

- 8. GENERAL. This Agreement constitutes the entire understanding between the parties regarding the subject matter hereof. Solace reserves the right to modify this Agreement upon written notice to Licensee. Any such modifications shall become effective thirty (30) days after notice is delivered to Licensee. If Licensee objects to any modification, Licensee's sole remedy shall be to terminate this Agreement prior to the effective date of the modification. In the event any provision of this Agreement is deemed unenforceable, this Agreement and all licenses and rights granted hereunder shall immediately terminate. Solace's failure to enforce any provision or exercise any right hereunder shall not be construed as a waiver of any subsequent breach of that provision or as a waiver of any other right.
